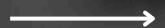

### **Approx 25,000 EURO : EXTRA COST OF PER ACRE LAND**

The surrounding land can be acquired for EUR 25000 per acre but same will need to be cleaned and fenced. Ideal will be to start with a combination of both so we can average the pricing

### **Processing time is 90-120 Days**

There is a Recurring Cost for Accountancy and Virtual Office every Year. The Main Applicant must have at least 2500 EURO per month in active income. If you're including your family, then also the Main Applicant needs to have a monthly active income of 2500 EURO.

- Obtaining Personal OIB (Director Identification Number).
- Obtaining Company Name (May take up to 15 days to check if the name is available).
- Preparation of Document set by the notary.
- Listing of Company activities (Articles of Association).
- Arrangement with Registered Translator.
- Signing of Company Formation Documents in the Notary.
- Obtaining Company OIB. (Company Identification Number).
- Opening of Company Bank Account.
- Depositing of Share Capital.
- Registration with Statistics Department
- Registration with Tax Department
- Registered Office Contract
- Contract with Accountant.
- Obtaining Company Court Order



# Service Itinerary
