Pathways to Mexican Residency

There are two primary ways to obtain a Temporary or Permanent Resident Visa, which can lead to Mexican citizenship:

1. Residency via Mexican Consulate (Non-Work Visa)
2. Residency via Work Visa (Employment in Mexico)

Why Choose Mexico for Residency?

Mexico is an attractive destination for expats, investors, retirees, and professionals due to:

- **Affordable Living:** Enjoy a lower cost of living compared to the U.S. and Europe.
- **Rich Culture & Scenic Beauty:** Experience stunning beaches, vibrant cities, and historical heritage.
- **Proximity to the U.S. & Latin America:** Easy travel with excellent global connectivity.
- **Tax & Business Benefits:** Favorable taxation for foreign residents and entrepreneurs.
- **Pathway to Citizenship:** Obtain a Mexican passport after a few years of residency.

Residency via Mexican Consulate (Non-Work Visa)

Apply directly at the Consulate General of Mexico by meeting one of the following requirements:

1.1 Real Estate Ownership

Own property in Mexico worth at least \$550,000 USD and provide: A notarized property title deed as proof of ownership.

1.2 Economic Solvency

Prove financial stability with one of the following:

- Bank Accounts/Investments: Minimum \$70,000 USD average balance for the last 12 months.
- Job or Pension Income: At least \$4,100 USD per month for the last 6 months.
- Documents must be certified by a bank, financial institution, or relevant authority.

1.3 Investment in Mexico

- Be a shareholder in a Mexican company with a minimum investment of \$275,000 USD.
- Provide proof of business assets, contracts, invoices, or business registration.

1.4 Invitation from a Mexican Institution

- Letter from a public or private Mexican organization inviting you for an unpaid activity.

Step by Step Process

Step 1: Apply at the Mexican Consulate

- Submit all required documents and attend an interview.
- Pay consular fees (~\$45 USD)

Step 2: Enter Mexico & Exchange Visa for Resident Card

- Within 30 days of arrival, apply at the National Immigration Agency and pay the required fees:
 1. \$275 USD (Temporary Resident Card)
 2. \$340 USD (Permanent Resident Card)

Step 3: Maintain & Renew Residency

- Temporary Resident Card Validity: 1 year (renewable for up to 3 additional years).
- Upgrade to Permanent Residency: After 4 years of temporary status.

Residency via Work Visa (Employment in Mexico)

This pathway is best suited for:

- Individuals seeking employment in Mexico.
- Companies looking to sponsor foreign workers.
- People interested in long-term work opportunities in Mexico.

Requirements for a Work Visa

To apply for a Temporary Resident Work Visa, you need:

- A valid job offer from a Mexican company.
- The company must be registered with the National Immigration Agency.
- The company must apply for your Work Visa Authorization.

Step by Step Process:

Step 1: Employer Applies for a Work Visa Authorization

- A Mexican company applies for Work Visa Authorization at the National Immigration Agency.
- Once approved, the company sends you an official visa invitation letter.

Step 2: Obtain a Temporary Resident Visa from a Mexican Consulate

- You must schedule an appointment at the Mexican Consulate.
- Submit your documents and attend an interview.
- Pay the Visa Fee (~\$45 USD).
- Once issued, the visa is valid for 6 months (single entry only)

Step 3: Enter Mexico & Apply for a Temporary Resident Card

- Within 30 days of arrival, exchange your Work Visa for a Temporary Resident Card at the Immigration Agency.
- Pay the Resident Card Fee (~\$275 USD).
- You are now legally allowed to work in Mexico.

Step 4: Maintain & Renew Work Residency

- First Work Permit Validity: 1 year.
- Renewal: Extend for up to 3 additional years.
- Upgrade to Permanent Residency: After 4 years of temporary work status.

Cost and Service Fees

Residency Services

- Visa & Residency Assistance
 1. **Consular Visa Filing** (Remote Support) – \$1,000 USD
 2. **Immigration Agency Fees** – \$275-\$340 USD
- Business Setup & Work Visa
 1. **Company Incorporation** – \$3,000 USD (+Notary Fees: \$800-\$1,000 USD)
 2. **Immigration Registration for Business** – \$1,000 USD
 3. **Work Visa Authorization** – \$1,000 USD
- **Document verification and due diligence fees** - \$13,660 USD

Additional Immigration Services

1. Temporary Resident Card Renewal – \$1,000 USD
2. Exchange Temporary to Permanent Resident – \$1,000 USD
3. Family Residency Application
 - First family member – \$1,000 USD
 - Additional family members – \$700 USD each
 - Mexican Citizenship Application – \$2,000 USD

Pathway to Mexican Citizenship

Eligibility:

- Maintain resident status for 5 years (or only 2 years for Spaniards & Latin Americans).
- Live in Mexico for at least 2 years (must not leave for more than 6 months).


Citizenship Application Process

- Submit application to the Department of State.
- Processing time: 5 months.
- Government fee: \$450 USD.

Benefits of Mexican Citizenship:

- Mexican Passport: Visa-free access to 150+ countries.
- Dual Nationality: Keep your original citizenship.
- Property Ownership: No restrictions for foreigners.
- Legal & Voting Rights: Enjoy full citizen privileges.
