Entrepreneur Residency Program

The Entrepreneur Residency Program is designed for business owners and investors looking to establish or expand their business operations in Thailand. This program provides legal residency, business setup assistance, and work permit facilitation, ensuring a smooth transition into the Thai market.

Key Services Provided:

- Company registration and legal setup
- Virtual office solutions for foreign entrepreneurs
- Social security and VAT registration compliance
- Assistance in converting a visa to Non-B in Bangkok
- Work permit application for foreign business owners

Processing Timeline:

- Company Registration: Minimum of 2 weeks
- Bank Account Opening: 7 days after registration

Cost:

- Total fee: 150,000 THB (includes all administrative processes and legal assistance)
- Requires 2 founders (1 Thai national, 1 foreigner).
- Minimum 2 million THB capital investment per work permit

Additionally, business owners may require specific licenses to operate in Thailand.

Available business licenses include:

- Restaurant and Alcohol License
- Import and Export License
- Travel Agency License
- Education License
- Recruitment License

License fees start from 22,500 THB, with additional audit fees applicable.

Retirement Residency Visa (Non-O)

The Thailand Retirement Residency Visa (Non-O) is tailored for retirees who wish to settle in Thailand for an extended period. It offers long-term stability and a relaxed lifestyle in one of the world's most sought-after retirement destinations.

Eligibility Requirements:

- Applicant must be 50 years or older
- Must fulfill one of the following financial requirements:
 - Deposit of 800,000 THB in a Thai bank (held for at least 2 months before application)
 - Monthly income of at least 65,000 THB
 - A combination of deposit and annual income totaling 800,000 THB
- Must have a passport valid for at least 6 months
- Medical and police clearance may be required

Benefits of the Retirement Visa:

- Valid for 1 year, renewable indefinitely
- No work obligations
- Allows purchase of property and long-term investments in Thailand
- Eliminates frequent visa runs with in-country renewal options
- Several options to own a business or apartment

Fees & Processing:

- Initial 3-month visa: 90,000 THB
- Annual renewal fee: 45,000–50,000 THB

One-Year Non-B Visa Extension

The One-Year Non-B Visa Extension is ideal for professionals and employees working in Thailand. It provides legal work authorization and residency benefits to foreign nationals.

Documents Required:

- Valid passport with at least 6 months remaining
- Employment contract and approval from the Ministry of Labour
- Company registration and shareholder details
- Financial statements of the employer

Processing Fee:

- 55,500 THB
- Additional eVisa charges of 6,000 THB if applicable

Destination Thailand Visa (DTV)

The Destination Thailand Visa (DTV) is designed for digital nomads, freelancers, and remote workers looking to stay and work remotely from Thailand.

Visa Features:

- Multiple-entry visa valid for 5 years
- Allows stays of up to 180 days per entry (extendable once per stay)

Eligibility Requirements:

- Proof of employment or freelance work
- Minimum financial holding of 500,000 THB
- Application through Royal Thai Embassy or e-Visa portal

Processing Fees:

- Document preparation: 3,500 THB
- E-Visa application fee: 7,500 THB (varies by nationality)

Thailand Elite Membership Program

Eligibility Categories:

LTR visa with four applicant categories:

1. Wealthy Global Citizen:

Have at least USD1,000,000 in assets.

Have a personal yearly income of at least USD80,000.

Invest at least USD500,000 in Thai government bonds, foreign direct investment, or property

2. Wealthy Pensioner:

- Have a personal yearly income of at least USD80,000.
- Have a personal yearly income of at least USD80,000.
- Have a personal yearly income of at least USD40,000 and invest at least USD250,000 in Thai government bonds, foreign direct investment, or property.

3. Work-from-Thailand global professional:

- Work for a public company listed on a stock exchange or a private company with revenue of at least USD150 million for the last three years.
- Have a personal yearly income of at least USD80,000.
- Have a personal yearly income of at least USD40,000 and a graduate degree or own intellectual property or receive Series.
- A funding have at least five years' experience in the relevant field of employment.

4. Highly Skilled Professional:

- Work for a business in one of the targeted industries, a higher educational institution, research institution, specialized training institution, or Thai government agency
- Have a personal yearly income equivalent to at least USD80,000.
- Have a personal yearly income of at least USD40,000 and a graduate degree or special expertise relevant to the job assignment in Thailand.
- Have at least five years' experience in the relevant field of employment or hold a PhD in the targeted industry.

Note: all applicants must hold health insurance or social security benefits with at least USD50,000 coverage, or pay a USD100,000 deposit.
